What information we collect about you

How we collect information about you

We collect information about you in a number of ways:

Using your personal information for other purposes

Processing basis 4: The processing is necessary for compliance with a legal obligation to which the controller is subject.

Who do we share your data with:

How long we will retain your personal information for:
